The schedule of interview has been notified vide Notification 12/2023 dated 01.06.2023.

- (i) Provisionally Eligible candidates to make sure that they bring the relevant certificate/document in support of their candidature. If at any stage, it is found that the candidate has submitted wrong information in the Application form, then the candidature will be cancelled.
- (ii) Date of birth certificate.
- (iii) Marksheets and Certificates in support of the prescribed educational qualifications
- (iv) Experience Certificate as mentioned in your application (clearly indicating designation, from (date) pay details etc. Offer of appointment shall not be accepted as proof since the duration of service etc can't be ascertained) as applicable.
- (v) Caste/category certificate i.e. SC, OBC, EWS, PwD, ESM etc., if applicable
- (vi) Certificate in support of age-relaxation.
- (vii) No Objection Certificate from present department, if working in Govt organizations/ Autonomous bodies/PSUs etc.
