

# 1.4 National Institute of Design (Amendment) Act, 2019

National Institute of Design, Madhya Pradesh was brought under the ambit of National Institute of Design (Amendment) Act, 2019 (No 38 of 2019) after the assent given by President of India on 29 November 2019. The institute is authorised to award Bachelor's degree in Design (B Des), Master Degree in Design (M Des) and PhD degree in Design.

National Institute of Design (Amendment) Act, 2019 read in conjunction with the National Institute of Design Act, 2014 lays down the powers of the institute, teaching at NID MP, institute's authorities, powers of the Governing Council, Senate, source of funds, accounts and audit, provisions related to statutes and ordinances and such other information.

The First Statutes further amplify the provisions given in the Act and include powers of the Governing Council, standing committee to the Governing Council, Director, Senate, faculty streams, education and training programs, institution of fellowship, scholarships, medals, prizes etc, Academic advisory committee, Faculty forum, classification of the members of the staff of the Institute, selection committee for appointments, performance appraisal system etc.

The Ordinances form the framework for learning, teaching, assessment and other aspects of the student experience. They help to ensure a consistent and fair approach to education at the institute and lay down standards and policies that help in framing regulations in various fields such as academic integrity, evaluation methodologies, grading, resource utilisation, student code of conduct etc.

#### 2. STATUTORY BODIES

#### 2.1 Governing Council & Members


The Governing Council (GC) is the principal executive and policy-making body of the institute. It approves broad academic policies, programs, and monitors functioning of the institute. It is also responsible for general superintendence, direction, control of the institute and monitoring institutional performance. It is composed of a diverse group of individuals; comprising industrialists with wide range of experiences, senior government officers, members of the institute community, eminent educationists from various fields etc, who bring a large variety of perspectives and expertise with them.

The GC considers and passes the annual report, passes the annual budget, reviews the audited statements of accounts, makes Statutes concerning functioning of the institute, approves Ordinances and prescribes procedures to be followed by the institute in discharge of its functions. It also supervises academic and other related activities of the institute, reviews academic performance of students, monitors educational development, approves introduc-

tion of new academic programs etc. The GC appoints committees that it considers necessary for its functioning and has the power of entering into agreements with government and private organisations for receiving endowments, grants, donations, gifts etc on mutually agreed terms and conditions.

The GC sets academic standards, determines structure of the institute and oversees allocation of resources. It also ensures that the institute remains financially stable and sustainable by monitoring financial performance and approving policies about financial planning and expenditure. The Council also approves the standards for admission, studies, graduation; and oversees the academic integrity of the institute. It is also responsible for ensuring that the institute is accessible and inclusive and promotes equity & diversity.

The Governing Council has been constantly guiding NID MP to become a leading higher education institution in the field of design education, and to adequately serve the needs of its students and other stakeholders.








#### 2.2 Standing Committee of GC

Standing Committee of the Governing Council monitors, evaluates, advises, and provides insight and foresight with respect to all strategic, financial, governance, administrative, works and academic matters.

The Standing Committee may make recommendations on matters related to recruitment of employees, service conditions of teaching and non-teaching staff, annual accounts, budgeting, income, and expenditure, fixing limits on the recurring/non-recurring expenditure, infrastructure procurement and maintenance, construction of assets, regulatory compliances, quality policy, innovation & incubation, patents etc.

#### 2.3 The Senate

The Senate is the principal academic authority of the institute, responsible for regulating and maintaining the standards of teaching, evaluation, and research. It is also responsible for laying down the academic policies regarding maintenance and improvement of standards of teaching, extension, collaboration programs, cultivation of intellectual property rights, entrepreneurship, incubation etc.

The Senate at NID MP examines the matters related to admissions, instruction and examinations, curriculum structure and revisions, award of scholarships and prizes, grant of degrees, creation, restructuring and abolition of disciplines/ programs/ campuses etc. For this purpose, the Senate may constitute committees or working groups, who examine the specific tasks and submit their recommendations. The Senate also carries out periodical review of activities of various faculty streams and disciplines and recommends appropriate action for maintaining the excellence of standards of education at the Institute.


#### 2.4 Faculty Forum





# 3. ORGANOGRAM AND ACADEMIC WORKFLOW

#### 3.1 Faculty Stream

Faculty Streams at NID MP are a diverse community of competent, creative and skilled design professionals, who continuously aim to develop new design ideas and solutions to the design problems being faced by the industry and society. Each faculty stream works to develop critical awareness of various concepts listed in the curriculum, through hands-on research and discussion.

The faculties within each stream are experts in their fields, who provide students with the latest information, techniques, and best practices in their respective disciplines. This allows students to gain the skills and knowledge required to succeed in their chosen fields. Two or more faculty streams sometimes work together to offer interdisciplinary courses/ academic inputs, which provide students with more holistic understanding of design issues and the skills needed to address them. Students belonging to different disciplines conduct a number of activities/ performances and sometimes invite students of other disciplines also to get involved. This allows the student community to participate in activities and initiatives that are specific to their areas of interest and take advantage of the resources and opportunities available at the institute.

The Institute offers Bachelor of Design programs in three faculty streams. The broad focus area of each faculty stream is listed below:

#### Faculty of Industrial Design (FID)

The Faculty of Industrial Design specializes in educating students in the design and development of products, systems and services. The faculty is a dedicated team of extraordinary, innovative leaders who aim to bring new levels

of creativity, vision, and integrity to the Discipline. Students are taught concepts related to design theory, product design, materials and manufacturing, ergonomics and design for sustainability etc.

The Discipline ultimately intends to present to the customers user-friendly products with value and utility such as furniture, interior items, ceramic and glass products, toys and games, automobiles, etc. The aim is to produce graduates who have the skills and knowledge necessary to create well-designed, functional, and aesthetically pleasing products that meet the needs of users and society.

#### Faculty of Communication Design (FCD)

The Faculty of Communication Design is focused on teaching students about the principles, theories, and practices of visual and verbal communication. It deals with the extremely diversified media and multimedia platforms. The curriculum is designed to give students a strong foundation in design theory, while also providing hands-on experience in using design tools and techniques.

Students are taught the theory and practice needed to combine words, images and expressions to visually transmit information and project human experiences. They learn concepts related to graphic designs, animation, film and video communication design, photography, exhibition design, illustration, web design, advertising etc.

#### Faculty of Textile and Apparel Design (FTAD)

Faculty of Textile and Apparel Design is a unique stream addressing textile, apparel, fashion and interior accessories product designs. The program under this stream strike a balance in the domains of textile products development, apparel designing, lifestyle and fashion accessories and their merchandising. The programs offered under this stream are deep rooted in scientific processes of textile development, garment manufacturing technology, lifestyle and fashion accessories and its design. Students are trained to develop best standards both in traditional handcrafted sector and sophisticated modern technology-based textile, apparel and accessories industry. Faculty are specialised in textile, apparel, lifestyle fashion and accessory designs.

Faculty of Information Technology Integrated Design (FITID) - yet to start offering programs.

Faculty of Information Technology Integrated Design stream offers programs which are conceptualized around Information technology-based designs and offers design solutions with focus on design industry of future. This stream keeps track of emerging design scenarios to train students as innovators, who could understand requirements of the industry and apply design in creative ways to act as problem solvers.

## Faculty of Interdisciplinary Design (FID)-yet to start offering programs.

Faculty of Interdisciplinary Design (FID) stream focuses on the design-based need of non-design disciplines such as science, engineering, management, etc. and addresses them through specialized programs. Ideally most of the programs offered under this stream are considered as postgraduate studies, however in some cases, they may be offered at undergraduate level with suitable justifications.

The programs offered under this stream are based on the belief that successful leadership requires a broad understanding of the relationships between technology and people to foster and develop graduates who will be able to address and tackle major challenges that faces the society with transformative and multidisciplinary solutions.

# Faculty of Design Based Transdisciplinary Studies (FDBTS) - yet to start offering programs.

This stream focuses on Design-based Scientific Research, Design Management studies, Design Engineering, Design in social context, or any other areas where design will act as the critical agent for value and job creation.

#### 3.2 Management of the Institute

#### 3.3 Activity Chairpersons

Activity Chairpersons are the functional heads of certain centralized activities and responsible for carrying out activities under the specific functions that have been assigned to them. They are involved in decision making under these functions and making specific recommendations for improvement in teaching-learning, conduct of training programs, making short term and long-term strategies/ plans, conduct of research and development activities, undertaking outreach initiatives, ensuring the physical and mental well-being of the institute community etc.

The Activity Chairpersons are nominated by the Director under provisions given in section 22 of the First Statutes. Currently, the institute has the following Activity Chairpersons:

#### Functions of Activity Chairperson— Education and Training

Activity Chairperson, Education and Training facilitates creation of a learner-centric environment, conducive for quality education and ensures appropriate actions, that are needed for maintenance of quality of teaching-learning. He/she is in charge of all administrative and academic activities of educational programs with respect to all Faculty Streams and Programs. He/she controls, regulates and co-ordinates education and training activities to maintain standards of teaching and research at the Institute. He/she also monitors students' disciplinary matter & grievances.

#### 2. Functions of Activity Chairperson— Strategy and Planning

Activity Chairperson, Strategy and Planning determines the long-term plans of the Institute, monitors adherence to goals, strategies, policies, and action plans. This office is responsible for making strategy and plans as per the vision, mission, and objectives of the Institute. He/ she is responsible for developing, executing, and sustaining strategic initiatives and special projects; especially those that require broad collaboration amongst various departments & offices and participation of stakeholders. AC (S&P) also plans and coordinates long term perspective plan, suggests inputs for policy development and carries out evaluation of

programs for growth and development of the institute.

#### 3. Functions of Activity Chairperson— Research & Development & Knowledge Management Centre

Activity Chairperson, Research & Development & Knowledge Management Centre works to foster research attitude and impart researchbased teaching practices in the institute. This office also initiates steps to encourage research collaborations within the departments and with other institutes for pioneering research in field of design. He/ she identifies opportunities for externally funded R&D projects, ensures that project proposals are prepared, applications for funding are submitted, follow up with the funding agencies is carried out etc. AC (R&D KMC) also submits periodic reports to the Director on the progress of R & D activities, status of sponsored research project proposals and actions proposed to meet/exceed targeted performance.

### 4. Functions of Activity Chairperson— Global Outreach Cell

Activity Chairperson, Global Outreach Cell is a vital link between the institute and external stakeholders and aims to continuously develop the connections with industry and business organisations. He/ she plans and implements a mechanism for collaboration with industry, other organizations, and academia. He/ she also encourages the faculty to utilize their expertise for consultancy services, develops mechanisms to exploit external partnership opportunities and monitors effective implementation of the consultancy policy. This office also deals with sponsored research, industrial consultancy, projects, and professional training etc.






#### 4. ACADEMIC DISCIPLINES

The program not only prepares to focus on the appearance of a product, but also on how it functions, is manufactured and ultimately the value and experience it provides for users.

The curriculum lays emphasis on the traditional values behind industrial design and latest trends in the industry for students to progress from



creating two-dimensional drawings to threedimensional mock-ups and models, to working drawings and prototypes that incorporate manufacturing considerations. By end of the program, a student learns how to conceptualize, design and improve the products, objects, tools, and devices that are used in various fields of life.

The design process involves stages of designing, modelling, prototyping and testing. At the Industrial Design workshop, which is well equipped with machines and equipment, students learn how to maintain a balance between elements to maintain innovation, aesthetics and functionality. It initially had areas associated with different processes related to metal, clay & ceramics, wood, plastics and other materials. However, continuous efforts have been made to augment the facilities by adding large number of machines and equipment, which are used to train the students on modern industrial design methodologies. The students further sharpen their creative abilities, visual and spatial awareness, knowledge of industrial processes, techniques, and three-dimensional conceptual abilities with a hands-on approach, under the watchful eyes of faculties and technical staff.

Currently, the Industrial Design workshop of NID MP has facilities related to various shops and sections such as carpentry, general workshop, machine shop, welding shop, ceramics and clay, IT-assisted lab, cutting & forming etc.

The learner is exposed to various sub-domains of this wide field through various studio/ lab assignments and he/ she learns to understand content in its cultural, social, ecological and economic context. Students are encouraged to work and experiment on various projects to convey multifaceted messages and emotions.

# 4.4Bachelor of Design B.Des (Textile and Apparel Design)

Textile and Apparel Design (TAD) program is a unique program addressing textile, fashion, and interior design requirement in its broadest spectrum. The program strikes a balance in the domains of textile product development and apparel designing. It is deep rooted in scientific process of textile development and garment manufacturing technology. Students develop calibre and potential in both traditional handcrafted sector and sophisticated modern technology of textile and apparel industry. The program also strikes a balance with inputs in the areas of the art of design, the science of chemistry and the perspective of history in a rich, challenging learning environment at the creative forefront of the textile industry.

The students learn to explore various processes in the fields of textile and apparel, in both manmade and natural fibres. The program content includes historic context of textile and apparel, composition, ideation, basic loom structures, loom set ups, creation of fabric, sewing & garment construction techniques, pattern making etc. Students learn the skills of cutting, sewing, draping and develop adaptive clothing for various uses.

"Textile & Apparel" is not only for style statement, fashion, or modesty. It is a very basic element for the impression of the individual. At macro level, it covers visual culture, tradition, protection, and Identity. Textile & Apparel Design Professionals work with Retail brands, Crafts Sector, Media Houses, Export houses, Buying houses, Design studios, Online stores, Global brands, Films, Theatrical and performance costume providers, Entrepreneurs, and educational institutions etc. The program is focussed at training designers who would create new job opportunities and contribute to the economic growth of our country.

### **TAD Workshop**

The Workshop has machines like Tabletop loom, Jacquard loom, Block printing table, Screen Printing table, Screen frames, Screen Exposing machines, Curing machine, Steaming machine, Latest stitching machines, overlock stitching machines, Pattern making tables, GSM cutter, Beasley balance, Electronic twist tester, EPI & PPI counter, Analytical Balance, Transfer printing machine, Vacuum iron table, Standing Steam iron, Freeze, Washing machine and Different size of dress forms. In the textile workshop, students can work on the whole pallet from analogue to digital and progressively learn from the classic textile tool disciplines of weaving, knitting, and printing to modern architectural materials.




### 4.5 Quality Management

#### 4.6 Admissions

National Institute of Design, Madhya Pradesh admits students on the basis of a competitive admission process, which is centrally conducted for all the five NIDs, and examines creative understanding of the candidates. The first step is to clear the Design Aptitude Test (DAT) Prelims, after which the candidates are called to appear in Design Aptitude Test (DAT) Mains exam, to assess their design aptitude and skills. Based on the overall performance in DAT prelims and mains, a merit list is prepared and candidates are offered admission to the institute. This is intended to create a more diverse student base and foster inclusiveness by admitting overseas students. International students are expected to bring cultural diversity, an international perspective and will help to prepare our students for a globalized world.

### 5.1.2 Memorandum of Understanding

### **MoU with AIIMS Bhopal**

A Memorandum of Understanding (MoU) for academic collaboration and project partnership was signed between the National Institute of Design, Madhya Pradesh (NID MP) and All India Institute of Medical Sciences, Bhopal (AIIMSB) on September 20, 2021 at the AIIMS Bhopal campus. The partnership aims to foster collaborative academic, research, and project related activities through exchange of information, articles, reports and teaching materials etc. It shall also facilitate contact between investigators from the two institutions in the fields of Health Sciences and Design. The collaboration shall enable both the institutions to exchange expertise and information for developing business infrastructure to service the industry needs in specific areas.

Prof. (Dr.) Sarman Singh, Director AIIMS Bhopal underlined the need to broaden the scope of teaching and innovation through such collaborative efforts and said that this MoU paves the way for jointly working in the fields of mutual interest, while translating the expertise in Health Sciences and Design into business practices.

Speaking on the occasion Prof. Dhiraj Kumar, Director, NID MP said that the main objectives are to recognise each other's strengths, work on mutually beneficial projects and collaborate to establish facilities such as technology promotion centres, incubators, accelerators etc. Both the Institutions shall now be able to facilitate synergised knowledge transfer for benefit of the industry in Central India.

Objectives of the MoU are as under:

### **General Objectives**

- To exchange information, articles, reports and teaching materials in order to support the educational programs of each institution in the field of professional competencies.
- 2. To strengthen and encourage communication and collaboration in education and research between members of the two institutions.
- To stimulate contacts between investigators from the two institutions in the fields of Health Sciences and Design.
- 4. To develop academic projects such as collaborative research, teaching, technical cooperation, evaluation and publications. The human and technical resources which will contribute to designing and operating these academic projects shall be specified from each institution. Also, the mechanism and actions to evaluate, supervise and utilize the products of the aforementioned academic projects shall be jointly established.
- To promote bilateral cooperation in research and education in the fields of Health Sciences and Design, involving:
  - a) Teaching and exchange of researchers
  - b) Organize lectures, seminars, symposium, meetings etc

- c) Development of projects of common interest
- d) Visits of faculty and students for the mutual benefits of both institutions
- e) Cooperation in conduct of research (except finances)
- 6. Exchange of expertise and information for development of business infrastructure for servicing industry needs in specific areas.
- 7. Support technology promotion centers, incubators, accelerators, and other such initiatives by promoting professional development of these centers and facilitate knowledge transfer to strengthen industry in Central India.

- 1. To develop learning opportunities through courses, seminars, workshops, and other means to pursue activities related to academic programs from both institutions.
- 2. To facilitate visit by students between institutions to learn professional competences, as well as participating in electives.

#### **MoU with FIPS**

A Memorandum of Understanding (MoU) was signed by the institute with Foundation for Innovative Packaging and Sustainability (FIPS) on 21 Jan 2022 with the following objectives:

 To identify possible avenues and establish the basis of collaboration where it is mutually beneficial, however within the context of each party's mandate and existing technical, financial & legal obligations and further, without adversely affecting in any manner,

- the current corporate and legal relationships either party may have.
- To this end, the Parties agree jointly to explore and coordinate activities of mutual interest that will be implemented in conformity with the regulations and policies of both Parties. The purpose is to establish a formal basis of cooperation between the Parties in a collaborative effort to promote skill development, information and knowledge delivery and capacity building.
- 3. Without limitation to the generality of the objective(s), the areas of collaboration will include:
  - a) To promote Human Recourse development through different module of Training program in the field of "Packaging Design" by providing technical knowledge and expertise to the students of Bachelor of Design of NID MP.
  - b) To support the research Projects related to the field of "Packaging Design" by way of providing technical expertise to meet the objective of the research project with mutual benefit.
  - c) To establish "Package Design Incubation Centre" for providing 'First-hand Knowledge" to the students of NID MP and to stimulate for "Start-Up" business with sustainable approach with the following scope and operational Framework for the benefit of NID MP students.
    - I. The scope of the centre would cover to assist the start-ups in achieving growth by providing guidance and mentorship by FIPS to disseminate the "Knowledge" on properties and qualities of different types of packaging materials to select right kind of substrates for "Structural Design" of a package for a specific product by considering

the physical, mechanical and optical properties of the substrate material and to enable the package to sustain against all kinds of hazards which might damage the package design as well as the product during handling, storage, transportation and also facilitate them for smooth transition of startups from the ideation phase to commercialization.

- ii. The scope would also cover to assist the Start-ups by connecting them with the entrepreneurs for consultancy projects in collaboration with FIPS and facilitate "Startups" for sustainable business growth.
- iii. The centre would also organise "Pack-Design Award" Contest at National level with the aim of offering an opportunity to the students of NID MP and other Institutes dealing with Design who have the talent in creative packaging design to recreate innovative packages under "student Category" for the encouragement of the students and also to get recognition.
- a. The "Pack-Design Award" Contest would also invite the "Design Entry" in terms of cost effectiveness, user-friendliness, Convenience features and eco-friendliness. from the Packaging user industries at national level to participate into this contest to get a national recognition for a particular Package Design by NID MP which would ultimately help to get the benefit by the industries for their business growth.
- b. FIPS would be the "Partner" with NID MP for organising this "Pack-

- Design Award" Contest in terms of administration support, connecting with packaging industries to get the "Design entry" for the contest, technical support as "JURY Member" for the evaluation of "Winner" and also to organise "Pack-Design Award Ceremony" program.
- c. It is "Pack Design Award" would be organized annually so that the winning entries would also be eligible to participate into "World Star Contest" which is organised by World Packaging Organization (WPO) in collaboration with World Design Organization (WDO).
- d. Creating a Centre of Excellence on "Packaging Design" for stimulating entrepreneurial idea generation for high end products on display and provide information about where technical assistance, equipment, venture capital and other financing can be sourced. Relevant business plans and information about potential market linkages will also be made available. Help potential entrepreneurs undertake design and prototype development.
- e. Support commercialisation of high potential package designs in various sectors. This will help provide market linkages for such products.
- f. Both the parties may also support each other to provide advisory support for technical and commercial appraisal of the projects supported by their respective institutions.
- g. Both the parties will complement information & knowledge that can be used to draw up policy inputs for



presenting the same to the state governments and relevant national ministries through participation in events organised by either of the parties or jointly or by other parties where one of the two parties are invited to present their inputs.



# 5.5 Initiatives taken by the institute during COVID- 19 and Human Resource Development

Outbreak of a more deadly second wave of the COVID-19 pandemic and nationwide lockdown was a testing phase for the Institute. Physical teaching learning activities were suspended, and the students were sent back home on 22 Mar 2021. The second wave posed significant challenges to functioning of the institute, which forced us to close the campus for physical learning for a significant period. NID MP initially allowed functioning of all offices in fully online mode, and later when effect of the pandemic reduced somewhat, resorted to making attendance rosters to ensure that only those employees who were required at the workplace, where called to the campus.

During suspension of physical learning activities, online learning was resorted to. Alternative teaching methods, such as online discussions, online visits to museums/ art galleries/ design exhibitions, interactive assignments and online interaction with experts etc. were organised to engage students in the learning process. Virtual studio sessions allowed students to collaborate with their classmates and faculty in real-time. Interactive drawing and annotation tools were used by the faculty to help students to learn and practice their skills in a virtual environment.

NID MP provided students with remote access to online tools and software so that learning was not hampered. Online portfolios enabled the students to showcase their work and receive feedback from faculty and peers. Video lectures enabled engaging and interactive presentations, including demonstrations and examples, to support student learning. Synchronous and asynchronous learning approaches were used to accommodate the different schedules and learning styles of the students.




Students also had to face difficulties due to online learning of practical inputs, financial issues and mental health concerns due to illness of near and dear ones. The institute provided assistance by taking services of an online mental health support services provider to conduct online awareness sessions, online counseling etc. to address the increased levels of stress and anxiety experienced by students and employees during the pandemic. Hostel fee was charged on pro rata basis and students were allowed to pay tuition fee in a relaxed manner, to provide relief to those, who were struggling financially due to the pandemic.

NID MP implemented strict health and safety measures such as mandatory mask-wearing and social distancing to protect students, faculty, and staff from the spread of COVID-19. A strict policy of no entry/ exit from the campus premises was followed when the infection was at its peak. To ensure the safety of employees, the institute allowed work from home. Faculty and staff were encouraged to participate in online workshops, webinars, and other professional development opportunities. Some of the employees obtained online certifications during this period. The institute remained in touch with controlling ministry, district administration and other organizations to access information and resources related to the pandemic and to develop effective responses to the challenges posed by it.

Guidelines on preventive measures to contain spread of COVID-19 in offices were issued to the employees. At the time of reopening the institute for physical learning on 13 Sep 2021, a comprehensive SOP was issued to the students. They were asked to get an RT PCR test carried out before the reporting to the campus. The students were kept under 14 days quarantine in hostels before commencement of classroom activities. Reopening of the institute after a long period came as a relief to the students, as after a long spell of online learning, they were eager to return to physical classes

and engage in hands-on learning activities. It also provided them with an opportunity to reconnect with their classmates, faculty and the campus community. It was observed that the return to in-person classes helped in alleviating feelings of isolation and anxiety, which were common during the period of online learning. The social interaction and support provided by the physical classes was found to be beneficial to students' mental and emotional well-being. The students reported that re-commencement of physical learning activities allowed them to better understand and retain design concepts, receive real-time feedback and engage in interactive discussions with faculty, technical staff and classmates.

The institute was briefly closed again for physical learning activities from 14 Jan to 19 Feb 2022 due to surging COVID-19 infections in the city Bhopal.

### 6.2 Campus and Infrastructure

NID MP is known for its excellent campus and modern infrastructure and is home to some of the most advanced teaching facilities in the field of design education. The campus is located adjacent to the Acharpura Industrial Area in Bhopal. The institute has been constructed on a piece of land admeasuring 29.49 acre, against the backdrop of Vindhyanchal hills. A number of facilities and services have been created for the students to succeed both academically and socially other than the academic activities, NID MP hosts a wide range of recreational activities and social events round the year.

The institute understands the importance of infrastructure for creating positive and conducive atmosphere for students' learning. Our classrooms are equipped with modern learning tools such as AV systems, projectors and Wi-Fi hotspots. The workshops, studios and labs are well-equipped with state-of-the-art machinery and equipment for supporting the students to translate their classroom learning into practical outputs. IT Lab of the institute has the most modern workstations and cintique systems, loaded with a variety of software, which allow the young designers to experiment with their imagination in a variety of forms. NID MP Library has one of the most modern collections of the books on design, art, crafts, culture and other related subjects. It also provides access to e-books, e-resources, newspapers and magazines to the institute community.

#### Administrative Block

The Administrative block houses the institute's administrative offices, which provides all types of support to students & employees. Office of the Director provides overall leadership and direction to the institute. Offices for the Registrar, CAO, CFA, academic services, administration, establishment, procurement, estate/ works, store, finance & accounts, IT services etc are

also located in this block. It has a conference hall with a seating capacity of 20 to hold various meetings with the Director.

Students may contact these offices for matters related to their admission, fee payment, scholarship, results and any other administrative requirement.

### **Academic Block**

The Academic Block is used for conducting classes, lectures, seminars, group discussions, conferences, symposiums, and other academic activities. It has spacious and well-lit classrooms, discipline-specific labs, studios etc. built to facilitate effective teaching learning. The user-friendly academic environment makes it possible for the students to concentrate on learning in an interactive environment. The block also has 29 faculty seating spaces. Rooms have been allotted to the visiting medical officer, counsellor, and the Design Shop.

### **Workshop Block**

the Workshop Block is used for conducting hands on training with the help of various machines and equipment, as well as for conducting practical sessions related to design education. The Industrial Design (Ceramic, Pottery, Carpentry etc.) and Textile & Apparel Design workshops provide hands- on learning support to students under the guidance of highly trained design professionals, instructors and other experts.

The workshops are used to equip students with the skills and knowledge needed to become successful in the design industry. Students use the resources to develop their own design portfolios, gain valuable experience, as well as collaborate with other students.

#### **IT Centre**

A good computer centre is central to efficient learning in a design institution. IT centre at the



institute enables NID MP to provide students and faculty with the necessary technology and resources to support their studies and research. It also provides access to a range of IT services, which can be used to enhance the educational experience.

The Centre is equipped with state-of-the-art technological resources to support the IT related requirements of the Institute. It facilitates internet access to the institute community through a mix of networking & Wi-Fi devices and provides technical and systems support for running the Institute's information systems. It is equipped with workstations, Cintiq drawing pads, printers, networking peripherals etc.

### **Knowledge Management Centre (KMC)**

Knowledge Management Centre (KMC)/Library at NID MP provides a wide range of resources and services to students and faculty. It provides physical and digital resources and access to research materials needed for their studies and research. The KMC also provides a quiet space for studying, researching, and collaborating. The Library at NID MP is an important part of the institute community, and acts as a gathering place for students, faculty, and staff.

KMC at NID MP also performs the functions of identifying, evaluating, procuring and making the learning resources available to the institute community. The KMC is built on most modern lines, fully air-conditioned and computerized, equipped with ergonomically designed furniture & fittings and managed by a highly dedicated team of professionals. The KMC caters to the information needs of the institute community by offering a wide range of services with the help of open-source Library Management Software "KOHA".

KMC has created the digital repository of the institute by using open-source digital library software "DSpace" to preserve all in-house academic, research, and administrative outputs, i.e. photo gallery of the institute events,

in-house publications, policies, and newspaper clipping related to institute, etc.

KMC has also developed its own website/portal, which is accessible on the intranet and provides access to various digital contents of e-books, e-journals, e-magazines, e-newspapers, audiobooks, etc. Library Collection at NID MP is given below:

#### **Auditorium**

NID MP Auditorium serves a wide range of purposes from hosting large events and lectures to providing a space for performances and rehearsals. It has a seating capacity of 510. Other than screening course curriculum related documentaries/ movies, the facility is used for conducting short term training programs, workshops, expert/ guest lectures, professional seminars, conferences, presentations, meetings, orientations etc.

Special acoustical design panels facilitate high clarity and clear sound across the entire vocal range, eliminating all potential ear strain to the audience. Lighting system includes front lighting, foot lighting, spotlights and a projection room with manual and programmable lighting controls.

It is an important part of the institute's culture,

acting as a place for students to gather and share experiences. It also provides a venue for the cultural club of the institute to perform and show their work.

### **Hostels (Girls & Boys)**

Hostels at NID MP provide a secure, comfortable and convenient living environment to the students. These provide a sense of community and allow students to interact with each other, from different backgrounds and cultures. The boys and girls hostels are five-story structures, having single and double occupancy rooms. High speed internet connectivity has been provided in all the rooms. Hostels have recreation rooms, indoor games, automatic washing machines, RO water supply, solar geysers and other amenities.

Hostels provide a safe environment to study and socialize, enabling students to make new friends, build networks and learn more about each other. Other than being infrastructurally sound, NID MP hostels provide sufficient scope for interaction and discussions. It is a common sight in the hostels to find senior students guiding the study/ project groups of juniors. Here at the institute, hostels are a great way to develop personal and social skills, as well as learn how to live independently.

### Students' Mess

The Students' Mess at NID MP provides meals and snacks to the students. The mess also serves as a social hub for them, providing a place to meet, eat, and socialize with fellow students. The Students' Mess has a seating capacity of 120 with a centrally air-conditioned dining hall. Modern kitchen equipment and utensils have been provided by NID MP for safe and hygienic cooking and serving process.

The mess services provider adheres to the highest standards of hygiene consciousness. Institute's Mess Committee takes utmost care while preparing the menu to ensure that food

items cover all the demographics. Through this, the mess helps to create a sense of community and belonging, which is an important part of NID MP experience.

### **Multi-Facility Rejuvenation Centre**

The Multi-Facility Rejuvenation Centre (MFRC) plays an important role in the life of the institute community by providing them with opportunities for physical, social and mental well-being. MFRC at NID MP provides the facility of gym, aerobics, zumba, yoga and music instruments to students and residents. Students use the facility to build strength, improving general fitness, yoga, meditation and recreation.

The centre also offers a variety of activities and services such as fitness trainer, indoor sports and social activities. It provides the students with a safe and welcoming space to relax and socialize with peers.

#### **Residential Area**

Employee residences at NID MP provide a sense of community for faculty and staff and help the institute in attracting and retaining the best and brightest. Employees staying inside have access to on-campus services, recreational facilities and other amenities. The open gym adjacent to the residential blocks is very popular among employees, their family members and students.

One Type V unit is used as an executive guest house. The Institute has 03 Type II, 03 Type III, 06 Type IV and 04 Type V workplace-convenient housing units for the employees.

#### **Medical Centre**

The medical centre at NID MP plays a crucial role in ensuring the wellbeing of the students and employees. It provides essential medical services, advice and support. It also helps to maintain a healthy environment on campus by providing information on health related topics



and health promotion initiatives.

Medical staff at the institute is responsible for providing first aid, administering vaccinations and providing health screenings. The institute has engaged a doctor on visiting basis for medical support. One male and female nursing assistant each take care of the medical needs of students and employees. A counsellor has also been engaged to provide mental health support services to the institute community.

# 7.7 Life at NID MP for its Residents



# Reopening of campus post COVID-19 pandemic

During the online learning phase at the time of COVID-19 pandemic, students were continuously demanding resumption of regular classes as and when possible. Most of them were of the view that for the practical input-based design education, physical classes were better in terms of efficiency, interaction and overall understanding. Despite the comfort of learning from their homes, they were eagerly waiting for the institute to reopen due to difficulties in terms of knowledge transfer and learning efficacy. As the situation improved after COVID-19 pandemic, students were called to the campus for resumption of physical learning activities between 22 Mar to 13 Sep 2021 and subsequently, from 14 Jan to 19 Feb 2022. While they were on the campus, the institute enforced social distancing measures, insisted that masks were worn at all times and increased sanitation and cleaning procedures. the students back, while following the COVID Related instructions.

A comprehensive SOP was issued to them for strict compliance. The following precautions were taken at the time of calling them back on campus:

- (i) Every student was required to get the COVID- 19 RT PCR test done before starting from the hometown and only the negative test report holders were allowed to commence the journey.
- (ii) Every student was required to install Aarogya Setu app on the smart phone.
- (iii) Student was required to carry 5 masks and cloth gloves while joining the institute.

- (iv) Student was required to bring a hand sanitizer (500ml).
- (v) Every student was asked to sign a selfdeclaration form for having read and followed the SOP, obtain parent's signature and submit along with COVID 19 RT PCR report.

Proper sanitization was ensured at the academic block, workshop block, library, mess and hostels. Cleaning and regular disinfection of frequently touched surfaces was carried out before the beginning of classes and at the end of the day. Teaching materials, computers, laptops, machines etc. were regularly disinfected with 70% alcohol swipe. Hand washing stations with facilities of liquid soap were created so that students could clean hands frequently. Physical distancing was maintained at all places and crowding was not allowed. For air-conditioning/ventilation, the guidelines of CPWD were followed and the temperature setting were kept in the range of 24-30 degree centigrade.

Since students came from different locations in the country, they were put under quarantine and their health was monitored for a period of 14 days before being allowed to attend physical learning. Thermal screening of all students was carried out on daily basis. Hygiene conditions were regularly monitored in kitchens, dining halls, bathrooms and toilets etc. Students were sensitized on self-monitoring of health and their psychological well-being was regularly monitored by counsellor and faculty members.

#### **Outdoor excursions/activities**

# Sports activities

Amidst the COVID-19 restrictions, students after following due precautions, engaged themselves in sports activities such as cricket, football, volleyball, badminton, table tennis and a variety of other sports and games. It helped them to stay fit and healthy, build team spirit and also have some fun. They also made use of the peripheral road in campus for morning/ evening walks. Students also made use of the fitness equipment available in the open gym and Multi Facility Rejuvenation Centre.

# Counselling

The Institute hired a counselling agency to provide psychological support to students during the times of distress. The agency offered services such as individual counselling, group counselling, tele-counselling and online counselling. Its counsellors were trained professionals, who were able to assess the mental health concerns of our students and provide guidance and support to help them to cope with their challenges. The counselling agency also organised online workshops and seminars to help the students focus on personal and emotional wellness.

Later, the institute engaged a wellness counsellor on visiting basis to conduct regular one to one sessions, in which various aspects related to mental health could be discussed. The counsellor has since been helping the students in management of emotions, stress, depression, anxiety and other mental health conditions. She uses evidence-based approaches such as cognitive behavioural therapy and other therapeutic techniques to help the students work through their challenges and make positive changes in their lives. She also helps the students develop resilience, self-awareness and self-esteem needed to reach their goals.

# 7.9 Good practices

Materials Management: NID MP remained committed to the principle of buying the best goods and services and following the provisions of GFR-2017. The Stores Section caters to the procurement and distribution of goods and services for academic and administrative departments. It performs store functions with the help of processes and procedures related to purchase, storage and distribution of materials. Accurate inventory records of all materials, including the quantity, value and location of the items are kept. Annual check of all assets and consumable materials takes place at the end of every financial year.

Estate office runs a preventive maintenance program to ensure that all materials and equipment are properly maintained and operational. Usage of material is monitored to ensure that inventory is being used in an efficient and cost-effective manner. As part of the institute policy to ensure transparency, accountability, financial propriety and fair competition, the following steps are taken:

- (i) Procurement of goods and services through GeM and central public procurement portal.
- (ii) Digital signatures acquired for some of the stakeholders and separate tender evaluation committees are constituted for each tender.
- (iii) Procurement of low value items through a local purchase committee.
- (iv) Specifications are kept as generic as possible. Through a system of pre-bid meeting, the prospective bidders can clarify their doubts and suggest changes in the tender.

Monitoring of vital health parameters of all employees is done on a weekly basis (generally every Monday). Monthly meetings are conducted by Administration with class representatives to understand their concerns and take corrective measures. Fire safety & awareness sessions are conducted for the institute community once in every semester.

# Separate Audit Report of the Comptroller & Auditor General of India on the Accounts of National Institute of Design, Madhya Pradesh for the year ended 31 March 2022

- 1. We have audited the attached Balance Sheet of National Institute of Design (NID) Madhya Pradesh, Bhopal as on 31 March 2022 and the Income and Expenditure Account for the year ended on that date under Section 19(2) of the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971 read with Section 25(2) of the National Institute of Design Act, 2014. The preparation of these financial statements is the responsibility of the Institute's management. Our responsibility is to express an opinion on these Financial Statements based on our audit.
- 2. This Separate Audit Report contains the comments of the Comptroller & Auditor General of India (C&AG) on the accounting treatment only with respect to classification, conformity with the best accounting practices, accounting standards and disclosure norms etc. Audit observations on financial transactions with regards to compliance with the Laws, Rules & Regulations (Propriety and Regularity) and efficiency-cum-performance aspect, etc., if any, are reported through Inspection reports/ C&AG's Audit Reports separately.
- 3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidence supporting the amounts and disclosure in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by the management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.
- 4. Based on our audit, we report that:
  - i. We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit.
  - ii. The Balance Sheet and Income and Expenditure Account dealt with by this report have been drawn up in the format approved by the Government of India under sub-rule (1) of Rule 4 of National Institute of Design, Madhya Pradesh (Form of Annual Statement of Accounts) Rules, 2020.
  - iii. In our opinion, proper books of accounts and other relevant records have been maintained by National Institute of Design, Madhya Pradesh in so far as it appears from our examination of such books.
  - iv. We further report that:



#### A. BALANCE SHEET

A.1 Fixed Assets (Schedule-6): ₹1,21,28,95,049/-Capital Work in Progress-₹1,08,93,50,533/-

A.1.1 The above includes an amount of ₹98.94 crore being expenditure incurred during first phase of infrastructure development at the Institute which included construction of academic blocks, library, admin block, hostel, residential buildings etc. The construction in first phase was started in the year 2016. The campus was inaugurated virtually in February 2019 and partially completed facilities have already been put into use since July 2019. The Institute has not yet capitalized the same and kept the expenditure of ₹98.94 crore under Capital Work in Progress.

Non-capitalization of the above assets has resulted in overstatement of Capital Work in Progress and understatement of Fixed Assets (Buildings) by ₹98.94 crore.

A.1.2 The above includes an amount of ₹97,38,50,533/- under Capital Work in Progress as on 01 April 2020. However, Utilisation Certificates submitted by NBCC Limited against the grant received reflected an amount of ₹1,04,97,45,384/- and Fund position of NBCC Limited indicating amount received from client (NID, Madhya Pradesh) up to 2019-20 was ₹98,94,46,000/-. Moreover, NID, Ahmedabad had shown ₹1,06,52,89,633/-as grant utilized¹ up to 31 March 2020 for the setting up of New NID campus at Bhopal.

These figures need to be reconciled to bring clarity in the accounts of NID, Madhya Pradesh.

#### A.2 Earmarked Fund (Schedule-2): ₹8,62,23,931/-Current liabilities (Schedule-5): ₹1,43,44,813/-

The above does not include an amount of ₹0.22 crore payable to the Ministry of Commerce and Industry on account of interest earned on Grants-in-Aid received during the year 2021-22.

During the year 2021-22, interest amounting to ₹0.22 crore was earned on Grants-in-Aid received by the Ministry which was booked as income as reflected in the Schedule-13 (Interest Earned) instead of showing it as current liability refundable to the Ministry.

This has resulted in overstatement of Income as well as NID MP Corpus Fund by ₹0.22 crore, and understatement of Current Liabilities by the same amount.

#### B. Grants-in-Aid

NID Madhya Pradesh had unutilized balance of grants amounting to ₹5.43 crore at the close of the year 2020-21 and received grants amounting to ₹20.15 crore under different heads (General: ₹5.35 crore, Salaries, ₹3.74 crore and Capital: ₹11.06 crore) from the

Ministry of Commerce and Industry during the year 2021-22. Out of this, NID Madhya Pradesh had utilized ₹18.97 crore (General: ₹5.35 crore, Salaries: ₹3.74 crore and Capital: ₹9.88 crore) and surrendered an amount of ₹6.08 crore to the Ministry, with the balance of ₹0.53 crore remaining unspent as on 31 March 2022.

- v. Subject to our observations in the preceding paragraphs, we report that the Balance Sheet and Income and Expenditure Account dealt with by this report are in agreement with the books of accounts.
- vi. In our opinion and to the best of our information and according to the explanations given to us, the said financial statements read together with the Accounting Policies and Notes to Accounts, and subject to the significant matters stated above and other matters mentioned in Annexure to this Separate Audit Report, give a true and fair view in conformity with accounting principles generally accepted in India:
  - a. In so far as it relates to the Balance Sheet, of the state of affairs of the National Institute of Design Madhya Pradesh as at 31 March 2022; and
  - b. In so far as it relates to Income and Expenditure Account, of the surplus for the year ended on that date.

# <u>Inspection Report on the Compliance Audit of National Institute of Design, MP since</u> inception to the year ended 31.03.2022.

#### Part - I

#### 1. Introduction:

National Institute of Design, Madhya Pradesh (NID MP) is an "Institution of National Importance" under Department for Promotion of Industries and Internal Trade (DPIIT), Ministry of Commerce and Industry, Govt. of India. The Institute has a 29.49 acres' residential campus at Acharpura in Bhopal.

#### 2. Organizational set-up:

As per NID Act. 2014 amended in year 2019, the body corporate constituting each institute shall consist of a chairperson, Director and other members of the Governing Council (GC) of the Institute. The Governing council (GC) shall be responsible for the general superintendence, direction and control of the affairs of the instituteand shall exercise all the powers of the institute not otherwise provided for by this Act, the statutes and the ordinances, and shall have the power to review the acts of the Senate. The Institute is run by a full-time Director who is assisted by Administration Staff such as Chief Administrative Officer, Controller of Finance & Accounts, Registrar and others, and Faculty Members.

## 3. Objectives:

NID MP currently offers full-time four year Bachelor's Programme in Design (B.Des.) with specialization streams of

- Industrial Design
- · Communication Design and
- Textile & Apparel Design

with a multi-disciplinary approach to design education.

#### 4. Capital structure

NID MP had commenced its first academic session with a batch of 57 students from its own campus at Acharpura in Bhopal in July 2019. The Capital Grant to the tune of Rs.

19.75 crores has been spent till date. The Institute is supported by the Government through grants sanctioned by DPIIT, Ministry of Commerce & Industry.

#### 9. Internal Audit:

Internal Audit of the Institute has been conducted for the year 2021-22 by Chartered Accounts firm SHAP & Associates, Gujarat.

#### 10. Risk and Threats:

Risk areas related to NID MP include procurement and annual maintenance contracts, TDS compliance, recruitments, compliance with Government Statutes and orders, financial propriety in utilization of Grants and internal resources.

#### 11. Status of Computerization:

NID MP has put in place varied IT infrastructure to automate the working process of the Institution. Many software applications such as Library Management System and accounting tools are being used in the Institute for the administrative as well as fulfilling educational needs. The Institute also has Digital Media Lab and Resource Centre equipped with latest digital equipment and ICT facilities to impart knowledge to its students.

#### 12. Government Audit:

The audit of National Institute of Design Madhya Pradesh was conducted under section 14 of C&AG (DPC) Act, 1971 by Audit Party consisting of Sh.Amit Kumar, Sr.AO, Sh. Ratnesh Kumar Srivastava, AAOand Sh. Himanshu Bansal, AAO from 09.11.2022 to 18.11.2022.

#### 13. Scope of Audit:

The audit period was from since inception of Institute (2019) to March 2022 of NID, MP. The audit was conducted taking the followings into consideration:

- Business rules like GFR, polices, procedures, Delegation of financial powers.
- Agenda/Minutes of Meetings of Governing Council, Internal Audit Findings, Annual reports.
- Guidelines and circulars by the Ministry
- Files related to recruitments, tax compliance, construction of campus, etc.
- · Other files furnished to audit


# 14. Sampling procedure:

Files related to contracts, recruitment, personnel files, procurement etc. were selected randomly.

#### Part-II A

## Para 1: Non-recovery of ₹ 1.25 crore as interest earned on the deposited funds.

The Department of Promotion of Industry & Internal Trade (DPIIT) awarded the work of planning, designing and construction of new campus of National Institute of Design at Bhopal to NBCC (India) Limited as deposit works on turnkey basis with agency charges @ 7% at an initial sanctioned cost of ₹ 64.18 crores (revised upto ₹ 105.92 crore). An MoU was executed (30th March 2015) between DPIIT and NBCC including the scope of work for submission of architectural designs along with building plan, construction of office building including civil works, interiors furnishings, lifts, landscaping, electrical, plumbing and sanitation and IT infrastructure. The said work was to be completed in all respects within a period of 18 months reckoned from the 15th day after the payment of advance or the date of handing over the site or sanction of estimate or approvals of drawing by the statutory authorities whichever was later. The first advance payment of ₹ 147.00 lakh was released on 10.09.2015 however, the construction work started from 22.01.2016. The campus was inaugurated on 22.02.2019 and the institute had commenced its first academic session from July 2019. The sanctioned project cost was ₹ 98.63 crore inclusive of NBCC Agency Charges @7% and the last tranche of the payment was released by DPIIT to NBCC during FY 2018-19.

Clause 5.5 of the MoU provided that the Employer shall give initial deposit of 33.33% interest free advance of the estimate cost on signing of the agreement. This initial deposit would be retained for adjustment against the last portion of the estimated expenditure. Executing Agency shall incur expenditure from this advance for execution of works immediately. When 70% (Seventy Percent) of the advance made to Executing Agency for the project is utilized Executing Agency shall submit the utilization certificate so that the next installment of 33.33% could be released. The utilization certificate may be accompanied by a statement of physical progress achieved. This procedure would be repeated till last installment is released. On completion of work, the accounts of the works shall be closed, and a final statement shall be submitted for settlement along with refund of excess deposit received, if any, audited by a Chartered Accountant. Further, Clause 5.6 of the MoU provided that "any bank interest accrued on the deposits/ advance shall be passed on to the Employer".

Audit observed that as per NBCC letter dated 09.03.2022 an interest of ₹ 1,24,58,173/- is earned on the deposited funds which will be adjusted on completion of work. Further, it 6 | P a g e



being a deposit work all the payment has been made by the DPIIT/NID, MP to NBCC and there being no security available with DPIIT/NID, MP the chances of recovery of ₹ 1.25 crore as interest earned on the deposit fund is remote. Further, NBCC is claiming that interest earned was partially adjusted against the outstanding dues, in this respect details of interest earned and approval of adjustment, if any, may be furnished to audit.

## Part-II B

Para 1: Irregularity in construction of new Campus of National Institute of Design, Bhopal and non-recovery of L.D. amounting to Rs. 10.6 crore form the contractor.

The Department of Promotion of Industry & Internal Trade (DPIIT) awarded the work of planning, designing and construction of new campus of National Institute of Design at Bhopal to NBCC (India) Limited as deposit works on turnkey basis with agency charges @ 7% at an initial sanctioned cost of ₹ 64.18 crores (revised upto ₹ 105.92 crore).

In this regard, the following is observed by audit:

1. As per clause 2 of MoU "the executing agency shall execute the work on a turnkey basis (Architectural services and Project Management Consultancy services from concept to completion) and hand it over within mutually agreed period of time from the date of signing of this MoU". However, it was observed that the NBCC has not given records such as Detailed Project Report, Master Plan, Estimates, architectural drawings for the construction of Campus to NID MP nor completed the project within the time i.e. 18 months from the date of start of construction (schedule date of completion being 22.07.2017). The work of construction of Amphitheater is still going on.

In the absence of necessary records, deviations from approved plan and/or any outstanding component of the project work could not be ascertained, if there was any. As per the terms of MoU, NBCC was to notify the completion of work and a joint inspection by DPIIT and NBCC was to be carried out, however, in absence of above documents handing over and taking over of the project is still pending.

2. Clause 10.2 of MoU provided that in case, completion of the project is delayed due to reasons solely attributable to the contractors/agency/ suppliers engaged for the project by the Executing Agency, the Executing Agency shall impose liquidated damages @ 0.375% on awarded contract value for each week of delay subject to a maximum of 10% of the awarded contract value and the benefit shall be passed on to

the Employer". It was observed that though there is a substantial delay in completion of the project (construction of amphitheater still going on) NBCC has not levied any liquidity damaged on the subcontractors and passed the same to the employer (DPIIT/NID MP), in terms of the MoU. This resulted in non-recovery of liquidity damages of Rs. 10.6 crore (10% of 105.92 crore). It being a deposit work all the payment has been made by the DIPPT/ NID MP to NBCC without having any security deposits, Hence, chances of recovery of liquidity damages are remote.

#### Para 02: Expenditure on construction without approval of competent authority.

NBCC vide its letter dated 11.03.2021 stated that they had executed additional work of  $\ref{thm}$  5.12 crore at site beyond the sanction amount (ie  $\ref{thm}$  98.63 crore) on the belief that overall sanctioned amount for the project is  $\ref{thm}$  105.92 crore and requested for release the balance payment of  $\ref{thm}$  7.17 crore ( $\ref{thmm}$  5.12 crore against already executed works +  $\ref{thmm}$  2.05 crore against balance works).

In this regard audit observed that:

- 1. Clause 3.4 of MoU provided "Executing Agency shall execute the works at sanctioned cost inclusive of agency charges for project management and planning, designing consultancy services. In case at detailed design/ execution stage, if there is an increase in this anticipated cost, the Execution Agency shall submit the details of the same with the supporting documents and technical/ administrative justification to the Employer" Further clause 3.14 of MoU provided that "Executing Agency shall submit the physical and financial progress report on monthly basis". However, the NBCC neither informed DPIIT before executing the additional work nor NID MP took prior approval of DPIIT before directing NBCC to execute additional work. This was in contravention of the clauses of the MoU agreement. The payment was later on regularized by DPIIT.
- 2. During execution of the contract work, NID MP directed NBCC that Amphitheatre needs to be revised completely as the current design and layout is not practical and has very limited seating capacity. NBCC submitted the proposal of completing the Amphitheater at ₹ 2.80 crore and the amount was release by DPIIT/NID MP to NBCC. The construction of Amphitheatre is still going on. It was observed that the initial DPR was approved by DPIIT/NID MP without assessing the actual requirement of the institute and revision in the design and layout of the amphitheater was done after incurring a substantial amount on the construction of the amphitheater as per original drawing and layout, which was later demolished for construction of new amphitheater as per revised



layout and plan. The value of demolished work was not found on records produced to audit. The value of demolished work of old amphitheater and amount of expenditure incurred on demolition/clearance of site may be provided to audit.

#### Para 03: Delayed/ Non-surrender of savings in the grants.

According to the OM of Ministry of Finance no. 2(12)-B (D)/2021 & 2(13)-B (D)/2022, the last date for accepting the Surrender of Savings anticipated in the grants for 2020-21 and 2021-22 was fixed to be 20<sup>th</sup> March and 21<sup>st</sup> March respectively. As per rule 56 (1) and 56(2) of Budget Manual (MoF), Departments of the Central Government shall surrender to the Finance Ministry, by the dates prescribed by that Ministry before the close of thefinancial year. The savings as well as provisions that cannot be profitably utilized should be surrendered to Government immediately when they are foreseen without waiting till the end of the year. No savings should be held in reserve for possible future excesses.

During the audit it was observed that NID, Madhya Pradesh had a savings of Rs. 2.84 croreand Rs. 5.43 crore at the close of FY 2019-20 and 2020-21 respectively in the head of account 'Government Grants'. NID, Madhya Pradesh did not surrender any savings of grant to the government of India during 2019-20 and 2020-21. Moreover, NID Madhya Pradesh has a closing balance of Rs. 0.53 crore under the same head in 2021-22 which is a clear violation of the OM of Ministry of Finance and rule 56 of Budget Manual mentioned above.

The persistent savings in NID, Madhya Pradesh indicated that the budgetary controls in the institutions were not effective and previous years' trends were not taken into account while creating the demand for grant of funds for the year.

#### Para 04: Non-recovery of Income tax due to non-accounting of perquisites in the salary.

As per the provisions of section 17(2) of Income Tax Act 1961 perquisite, inter alia includes (i) the value of rent free accommodation provided to the assessee by his employer and (ii) the value of any concession in the matter of rent respecting any accommodation provided to the assessee by his employer.

Further, Rule 3 of the Income Tax Rules provides as under:

Valuation of unfurnished residential accommodation provided by the employer: -

- (a) Union or State Government Employees -The value of perquisite is the license fee as determined by the Govt. as reduced by the rent actually paid by the employee.
- (b) Non-Govt. Employees- The value of perquisite is an amount equal to 15% of the salary in cities having population more than 25 lakhs, 10% of salary in cities where population as per 9 | P a g e

2001 census is exceeding 10 lakhs but not exceeding 25 lakhs and 7.5% of salary in areas where population as per 8 2001 census is 10 lakhs or below. In case the accommodation provided is not owned by the employer, but is taken on lease or rent, then the value of the perquisite would be the actual amount of lease rent paid/payable by the employer or 15% of salary, whichever is lower. In both of above cases, the value of the perquisite would be reduced by the rent, if any, actually paid by the employee.

Value of Furnished Accommodation- The value would be the value of unfurnished accommodation as computed above, increased by 10% per annum of the cost of furniture (including TV/radio/ refrigerator/ AC/other gadgets). In case such furniture is hired from a third party, the value of unfurnished accommodation would be increased by the hire charges paid/payable by the employer. However, any payment recovered from the employee towards the above would be reduced from this amount.

During the audit it was observed that NID MP provided the facility of furnished accommodation to its officials. Test check of salary sheet of the officials of NID MP revealed that the value of perquisite in respect of providing furniture in the residential accommodation was not taken into account for the purpose of calculation of the salary/ income tax of the employees. NID MP, being an autonomous Institution, was required to compute the value of perquisite in respect of providing furniture in the residential accommodation and accordingly deduct tax from the salaries of the employees who had been allotted accommodation by the Institute. Due to non-inclusion of perquisite value in salary/ Income tax calculation resulted in a short deduction of income tax.

Further, the following information may also be provided.

- 1. Residential quarter wise value of furniture provided by the NID MP in each quarter.
- 2. Employee (who had occupied the residential quarter) wise value of perquisite in respect of furniture provided in the residential quarters and value of tax implication on the same.

#### Para 05: Short recovery of electricity charges from residents of the staff quarter.

NID MP has taken the electricity connection from Madhya Pradesh Kshetra Vidyut Vitaran Co. Ltd. Bhopal, under Tariff Category HV-3.2. B Non-Industrial on 33 KV with sanctioned demand of 400KVA. During audit it was noticed that NID MP is paying for the electricity bills at electricity tariff which is applicable to Category HV-3.2. B Non-Industrial whereas the tariff which is being charged from the residents of the staff quarters within the campus is under the domestic tariff category. It was observed that the electricity charges/ rates being low under the domestic tariff category as compared to charges/ rates under 'Tariff'



Category HV-3.2 Non-Industrial' has resulted in under collection of electricity charges from the residents of staff quarters amounting to Rs. 0.77 lakhs (**Annexure 1**) for the year 2021-22. Further, the approval of the competent authority for recovery of electricity charges from the residents at domestic tariff category was not found on records.

# Para 06: Irregularity noticed in Procurement of Goods and maintenance of stock registers.

The National Institute of Design MP procured bags and pouches, T-shirts, Man zipper jackets, Man Hoodies jackets etc. with NID MP logo, for display/ sale during the events organized by NID MP, to spread awareness about the Institute in common public. The details of purchase made by the NID MP are as follows:

In this regard Audit observed the following:

- 1. As per GFR 2017, Rule 144 (iv) "Care should also be taken to avoid purchasing quantities in excess of requirement to avoid inventory carrying costs". The institute could not sale/ utilize the above items timely, this resulted in items worth ₹ 6.95 lakh (83.30% of total purchase) lying idle for a period of about 3 years in the store of the Institution. Also the quality of the items/ material lying in the store without being utilized deteriorates with laps of time.
- 2. Whether any provision has been made in the statutes of the Institute, for conducting purchasing and selling activity for profit. Kindly provide the copy of the provision.
- 3. Tote bags and pouches were recorded in fixed assets register (Vol -I page No.70) further 155 bags and pouches were issued to Textile and Apparel Department (TAD) and 460 no. of bag were issued to Admin/TAD. however, the same was not entered in their respective assets Register.
- 4. Details of sale/distribution/ available quantity of tote bags and pouches were not found on records.

5. TAD is not maintaining assets register properly i.e. details of issue of T-shirt, hoddies, zipper was not available in the assets register of TAD. It was also noticed that 15 Hoodies (with zipper) were missing the details of which were not available with the institution.

# Para 07: Irregularity noticed in Procurement of Goods through comparison with different category/specification of items

- A) As per the Clause 3 of Electrical Wires, Cables, Appliances and Protection Devices and Accessories (Quality Control) order 17 February 2003, "No person shall by himself or through any person on his behalf manufacture or store for sale, sell or distribute any electrical wires, cables, appliances, protection devices and accessories, which do not conform to the specified standards and do not bear Standards and do not bear Standard Mark of the Bureau on obtaining certification marks license." The BIS registration is essential for all electronics products/ appliances. Audit observed that NID MP procured (GEM order no. 511687723037598 dated 04.09.2020) "Unbranded both (single and twin) household Zig-Zag Sewing Machine Head" for ₹ 82240 (quantity 8 no @ 10280 per machine) which is available as per "BIS Specification No. IS 15449 (part 1): 2004". However, it was observed that the NID MP procured above item which do not have the mandatory BIS certification.
- B) Clause 3(B) (ii) of *General Terms and Conditions of GeM 4.0 (version 1.4)* states that Primary User shall be fully responsible and accountable for all actions/ transactions done by Secondary Users on GeM portal. Further, clause 3(B)(iv) states that "while making procurement on GeM, the Buyers shall judiciously search and shortlist items using filters such as quantity, technical parameters, delivery period, warranty period, consignee location(s), Seller's eligibility etc. as per their approved requirements. Placement of contract for a product /service uploaded by the Seller in any wrong/inappropriate product category is strictly prohibited and such contracts be treated, as null and void and such buying shall adversely affect Buyer Rating on GeM".

The NID MP have purchased various types of goods from GeM portal at rates which were arrived at on a faulty and incorrect comparison basis. The rates of the goods procured were compared with rates of wrong/inappropriate product category or compared with prices of items whose specifications were different from the desired specifications of the goods which were eventually purchased by the buyer department. Audit noticed such anomalies as explained in the table below:

As noticed above, the Institution has committed flagrant negligence while comparing specifications as well as price which resulted in the departments failing to get best competitive rates for the items procured by them. This also violated the *General Terms and Conditions of GeM* and rendered the contracts entered by them with the supplier as null and void and affected the concerned.

#### Para 08: Installation of DG set without assessing capacity requirement.

For proper electricity supply in the campus theelectricity connection of 400KVA (consumer code 3274191661) is available and for power back-up 4 DG set (2 pair of DG sets with one DG set of 750 KVA and other DG set of 400 KVA) at a cost of Rs. 1.55 crore were installed in the campus. In this regard audit observe the following:

1. Initially, as per requirement of electricity consumption in the institute, the connection demand was taken as 100KVA (30.05.2019). However, after start of the institute the connection demand was revised up to 400 KVA. At present the institute is functioning with the electricity load capacity of 400 KVA. However, the total load capacity of DG sets installed in the institute is 2300 KVA. This has resulted in installation of DG sets with load capacity which is more than the requirement and is unjustified, as huge expenditure was incurred in purchase and installation of these DG sets.

2. All these four DG sets are required to be kept in continuous use, as this is required to keep them functional. For keeping them functional, the institute have to incur expenditure on running and maintenance of these DG sets. If the electricity capacity requirement was assessed properly the running and maintenance expenditure on these extra capacity DG sets would have been minimized.

#### Para 09: Expenditure on additional work in excess of sanctioned cost.

The Department of Promotion of Industry & Internal Trade (DPIIT) awarded the work of planning designing and construction of new National Institute of Design at Bhopal to NBBC (India) Limited as deposit works on trunkey basis with agency charges @ 7% at an initial sanctioned cost of ₹ 64.18 crores (revised upto ₹ 105.92 crore). An MoU was executed (30<sup>th</sup> March 2015) between DPIIT and NBCC with the scope of work for submission of architectural designs along with building plan, Construction of office building including civil works, interiors furnishings, lifts, landscaping, **electrical**, plumbing and sanitation and **IT infrastructure.** The campus was inaugurated on 22.02.2019 and the institute had commenced its first academic session from July 2019.

Later the Institute realized that certain works are required to be carried out in addition to the works which were initially planned in the first phase. The Institute requested (26.02.2020) for additional fund under GIA capital in FY 2019-20 allotment to carry out works, which were affecting overall functionality, recreational activities and safety & security aspects of the campus. The details of works was as follows:

- a. Construction of Resource Centre & Amphitheatre
- b. Construction of Outdoor Sports Infrastructure: Football field, Basketball court, Volleyball court etc,
- c. Construction control room for monitoring CCTV system
- d. Illumination of areas in and around Residential Block
- e. Construction of Utility rooms for working staff of mess, housekeeping, security etc.

DPIIT sanctioned (12.03.2020) the grant of ₹ 7.30 crore and NID MP entered into agreement (10.09.2020) with NBCC for execution of above work at ₹ 7.69 crore with all the terms and condition, including payment to be as per the Original Agreement date on 30.03.2015.

In this regard Audit observe the following:

- The NID MP awarded the work to NBCC at ₹ 7.69 crore which was more than the sanctioned cost of ₹ 7.30 crore. In this regard it may please be clarified that from where the NID MP plans to recoup the estimated excess expenditure of ₹ 39 lakh.
- Reason for not negotiation with NBCC to carry out all above work within the sanctioned limit.
- As per progress report of execution of above work dated 04.03.2022 following deviation were noticed:

- 4. The schedule time for completion of the work was 18 months. However, till that time construction of Amphitheater was still going on. Clause 10.2 of MoU provided that in case, completion of the project is delayed due to reasons solely attributable to the contractors/agency/ suppliers engaged for the project by the Executing Agency, the Executing Agency shall impose liquidated damages @ 0.375% on awarded contract value for each week of delay subject to a maximum of 10% of the awarded contract value and the benefit shall be passed on to the Employer". NBCC did not levy any liquidity damaged on the subcontractors for delay in completion of the project work.
- The drawings of execution of above work and measurement book was not found on the records produced to audit.

#### **Notes Forming Part of Accounts**

#### 1. SIGNIFICANT ACCOUNTING POLICIES:

#### a. BASIS FOR PREPARATION OF ACCOUNTS:

The Annual Statement of Accounts and Balance sheet of the Institute are prepared based on the National Institute of Design, Madhya Pradesh (Forms of Annual Statement of Accounts) Rules 2020 notified by the DPIIT, Ministry of Commerce & Industry, Government of India vide Gazette notification no. G.S.R. 822 (E) dated 30.12.2020.

#### b. ACCOUNTING CONVENTION:

The Financial statements are prepared on the basis of historical cost convention, unless otherwise stated and on the accrual method of accounting except for fee collection and liability towards privileged leave and gratuity.

#### c. INVESTMENTS:

Long Term Investments are stated at cost.

#### d. FIXED ASSETS:

Fixed Assets are stated at the Cost. The cost includes invoice value, freight, octroi, and other incidental expenses relating acquisition.

#### e. GOVERNMENT GRANTS:

- (i) Government grants are accounted on the basis of sanction from Government Department.
- (ii) Government grant to the extent utilized towards capital expenditure, are transferred to the Capital Fund.
- (iii) Government grants for meeting Revenue expenditure are treated as income of the year to the extent of expenditure incurred.
- (iv) Un-Utilized grants are carried forward and exhibited as a Liability in the balance Sheet.



#### f. DEPRECIATION:

#### (i) RATE OF DEPRECIATION

Depreciation is calculated on Straight Line Method at the following rates:

- (ii) Depreciation on addition has been provided for the full year irrespective of date of acquisition.
- (iii) An amount from Capital Fund account was transferred to Income and Expenditure account to the extent of depreciation provided on assets acquired out of capital grant.
- (iv) Depreciation is not provided on assets sold during the year.

### g. FOREIGN CURRENCY TRANSACTION:

Transactions denominated in foreign currency are accounted for at the exchange rate prevailing on the date of transaction. The bank balance held in foreign currency is converted into Rupee at RBI rate prevailing on the closing day of the financial year.

#### h. CURRENT ASSETS, LOANS AND ADVANCES:

In the opinion of the Management, the current assets, loans and advances have a value on realization in the ordinary course of business, equal at least to the aggregate amount shown in the Balance Sheet.

#### i. INCOME TAX:

The income of the Institute is exempt under Income-tax Act 1961. No provision for Income Tax is therefore made in the accounts.

#### j. RETIREMENT/TERMINAL BENEFIT

Terminal leave encashment benefit and Death cum Retirement Gratuity (DCRG) to the employees are accounted for on cash basis.

#### k. Revenue Income

- (i) Various fees, except student activity fee, received from Students are treated as income for the year, as and when, these are realized.
- (ii) Interest on STDR is taken on accrual basis for the year.
- (iii) The revenue utilized towards the recurring expenditure, if any, incurred during the year has been shown at Sch 14 & 15 under the column "Non-Plan recurring expenditure".

#### I. CORPUS FUND

NID MP Corpus fund has been credited with the excess of revenue earned over and above the expenditure, if any, incurred from revenue, so earned, during the year. The portion of expenditure for the year, if any, over and above the Govt. Grant (recurring) was incurred from the revenue earned and difference has been transferred to Corpus Fund as shown in Sch 2 through Sch 16.

- 2. Contingent Liability for the year is ₹ 3,00,94,910/- (Previous year ₹. NIL) being income tax demand raised by the IT department for the year 2019-20. The rectification return has been filed.
- 3. Estimated amount of contract remaining to be executed on capital account and not provided for ₹ 40,97,105/- (Previous year ₹ 1,95,52,028/-) for construction of additional infrastructure.
- 4. Deficit for the year 2020-21 of ₹ Nil/- (For the previous year 2019-20 ₹ 20,69,496/-) has been debited to misc. expenses, as there is no specific govt. grant received for the same during the year.
- 5. Sch 15 "Other Administrative Expenses" includes an amount of ₹ 43,964/- as prior period expense of previous years.
- 6. Corresponding figures for the previous year have been re-grouped/rearranged wherever necessary.
- 7. Figures in the Final accounts have been rounded off to the nearest rupee.
- 8. New minor/sub head under various schedules have been included for better presentation of the Schedules and Annual Account.
- 9. Annexures to the Schedules has been attached for better understanding of the concerned schedules.
