## Recruitment for the position of Faculty on Contract basis (Advt. No.NIDMP/1-60/Faculty Rect./2021/01 dt 10 Mar 2021)

National Institute of Design Madhya Pradesh (NID MP) is an autonomous institution under the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Govt. of India. NID MP had been declared as an Institute of National Importance (INI) after the President gave assent to National Institute of Design (Amendment) Act, 2019 on 29th November 2019. The Institute invites applications from qualified and experienced person for engagement as Faculty on contract basis on a consolidated salary in its campus at Bhopal. The eligibility criteria and other details are tabulated below:

## **GENERAL CONDITIONS:**

- Selection will be through interview of shortlisted candidates.
- 2. 10 Candidates, who fulfill the educational qualification, age and experience criteria will be shortlisted on the basis of the following additional criteria, in the given sequence:
  - (i) Post Graduate Degree/Diploma in Design
  - (ii) More number of years of experience in the relevant field of Design
  - (iii) Experience of teaching in a Govt/ Autonomous educational institution imparting Design Education.

- (iv) Experience of teaching in a Govt/ Autonomous educational institution imparting Design Education.
- 3. List of shortlisted candidates shall be published on NID MP website.
- 4. The number of posts indicated above may vary based on further assessment of requirement. The decision of NID MP in this regard shall be final.
- 5. The appointment on contract basis will be initially for a period of one year, extendable further as per the requirements of the Institute, if the services of the candidates are found to be satisfactory. However, the candidate will not confer any right to claim absorption in regular establishment of the Institute.
- 6. The person shall be entitled to casual leave of 8 days in a year on pro-rata basis during the contract period. 2 Restricted Holidays shall also be allowed. Leave can't be carried forward or accumulated to the next year. No leave encashment for unavailed leave is allowed during the contract or on resignation or termination of contract. No other type of leave would be admissible.
- 7. Weekly off on Saturday & Sunday and other public holidays would be admissible.
- 8. Working hours/days and off will be the same as for the Institute.
- 9. TA/DA would also be admissible if deputed on outstation duty.
- 10. No other allowances/ perks or benefits would be admissible except the above.
- 11. All information submitted in the application will be verified with original documents at the time of interview. If any information provided by the candidate is found to be false or incorrect or not in conformity with the eligibility criteria, then his/her candidature is liable to be rejected/cancelled at any stage of the recruitment process.
- 12. NID MP reserves the right to cancel, restrict, enlarge the requirement without assigning any reason.
- 13. Police verification of the individual shall be done as per the latest instructions issued by the Govt of India. In case the police verification is received as negative, the contract of the individual shall cease to exist with immediate effect without any notice.
- 14. The Institute can terminate the contract at any time without prior notice and without providing any reason for it. However, in the normal course it will provide one month's notice to the individual. The individual can also seek for termination of the contract upon giving one month's notice to the Institute.
- 15. All modification/amendment shall be displayed on NID MP official website only at <a href="https://www.nidmp.ac.in">www.nidmp.ac.in</a> under career section. Therefore, candidates are requested to check the website for modifications/ amendment, if any, before appearing for selection process.
- 16. Before applying, candidates should ensure that they fulfill all the eligibility criteria mentioned in the advertisement.

- 17. Eligible candidates have to submit the duly filled-in application given in Annexure to this document along with all documents in support of educational qualifications, proficiency in computers and experience, addressed to "Registrar, National Institute of Design, Madhya Pradesh, Village- Acharpura, Eint Khedi, Post Arwaliya, Bhopal (MP) 462038".
- 18. Incomplete applications, those not meeting criteria and those received after the last date will be rejected. NID MP will not be responsible for any postal delay etc.
- 19. Candidates will have to correctly declare their Name and Date of Birth as mentioned in their Birth certificate or matric certificate. Candidates will have to declare their category correctly. Candidates must correctly enter the qualification details including date of acquiring qualification as mentioned in their certificates.
